Minutes of Scarning Parish Council Meeting held in Scarning Village Hall on 21 August 2023

Present: F Bradford (Chair), M Blackburn, S Bunn, C Hewson, M Steward. In attendance: N Hartley (Parish Clerk). One member of the public.

Public Participation

A member of the public asked who was responsible for cutting the hedge on Dereham Road. The Council noted it is the landowners' responsibility. It was noted there are overhanging branches over the footpath near Rushmeadow Road. The Council noted that residents can report such matters to Norfolk County Council, using the Report a Problem facility. The member of the public noted a report/request had been submitted and that Norfolk County Council said no action was necessary. The Council will chase cutting the overhanging willows further down the footpath. Cllr Bradford said she will speak with the school's head to see if the school wishes to encourage parents walking their children to and from school to report overhanging hedges/branches to Norfolk County Council.

The Council was asked if there is a Council What'sApp page. The Council will discuss this at its September meeting. It was noted that individual councillors cannot voice opinions on behalf of the Parish Council and that any statements made on social media have to be made with the agreement of the whole Parish Council.

The Council was asked about the grass cutting at Scarning Fen and ownership of trees on the path. The Clerk will meet the resident regarding these matters.

8 Blackthorn Drive Play Area

Cllr Bradford noted that she and Cllr Mallard had identified the National Lottery Community Fund as a possible source of funding. She had tried the Norfolk Community Foundation, but had been told there were no grants available.

It was **RESOLVED** that the Working Group can apply for a grant from the National Lotter Community Fund if its deadline falls before the Council's September meeting.

Cllr Turner (Breckland Council) is checking if there are any Section 106 monies available to the Parish Council through Breckland Council.

9 Flower Boxes

This was carried forward to the next meeting as Cllr Mallard was not able to attend the meeting.

10 Speed Watch

The Council is advertising for a new coordinator to run the Speed Watch Group. Cllr Blackburn said she is having a stall at the next coffee morning to advertise the Speed Watch Group and to find more volunteers/a new coordinator.

The Group collects data. As a result of the data collected, the Police now sends a police officer with a speed camera to Scarning every 2/3 weeks.

The Council will ask Norfolk County Council for the process to request a change in the speed limit.

Cllr Steward was asked if he was able to move the SAM2 into the older part of the parish.

11 Action to Trees on Shipdham Lane Playing Field

The Council was awaiting a response from the Tree Officer. This matter will be carried forward to the September meeting.

12 Social Media Policy Amendments

It was **RESOLVED** to approve amendments to the Council's Social Media Policy.

13 Report from Social Media Officer

Cllr Blackburn noted a video had been posted on social media showing the hedge cutting between Black Horse Close and Hill Rise. There was a complaint about dog owners not clearing up after their pets on the Water Meadows. The Council did not think there was a problem with dog fouling on the site and that there are enough dog bins and signs.

The Council will post on social media and its website that if residents have any complaints they should consult the Council website for a list of which organisation to contact that may be able to assist.

The Council will be positing a site plan of the Water Meadows on its website and social media showing which organisation is responsible for each area/facility.

The Council will add details of the Maui Waui Festival to its website and social media.

14 BCS Mower

This was carried forward to the September meeting as Cllr Abel was not able to attend the meeting.

15 Dereham Road

Cllr Richmond (Norfolk County Council) had reported the 'dip' in the road near Chestnut Road. Norfolk County Council said that no action is required at this time and they will continue to monitor as part of their scheduled inspections. Norfolk County Council has identified that there is an old culvert running under the road, but this is not currently seen as a danger or risk.

Cllr Bradford said she will speak with Cllr Richmond to see if any further action can be taken.
